#### A. INTRODUCTION

The Vietnam Competitive Authority (hereinafter referred to as the "VCA" or the "Investigation Authority") is responsible for administering the Vietnamese anti-dumping law. The law provides a mechanism for maintaining fair levels of import competition for Vietnamese producers when dumping causes material injury or threatens to cause material injury to an established Vietnamese industry. The law reflects Vietnam's obligations under the World Trade Organization (WTO) Anti-Dumping Agreement.

The VCA has initiated an investigation into claims by the domestic industry in Vietnam that dumped imports of certain stainless steel originating in or exported from the People's Republic of China, the Republic of Indonesia, Malaysia and Chinese Taipei have been and are causing material injury to the Vietnamese industry.

In compliance with the WTO Agreement on Implementation of Article VI of General Agreement on Tariffs and Trade 1994 (GATT 1994) and Vietnam Decree no 90/2005/ND-CP, in cases where the number of interested parties involved is so large that the determination of an individual margin becomes impracticable. Vietnam Competition Authority may limit their examination to determine individual margin to a limited number of interested parties. In order to do so, Vietnam Competition Authority issues the quantity and value questionnaire to related parties to collect information for purpose of sampling.

Please note that by providing information below, the company agrees to cooperate in this proceeding, this also imply to your related companies (if any). The non-cooperation of any of your related companies may be interpreted as a failure on your part.

#### Before completing the questionnaire you should read the following information:
